State Management Committee meeting

MINUTES*

*Please note that this meeting was an interim meeting – a quorum was present but it was not considered a full meeting of the 2020 SAERA SMC. As such the Minutes of the previous meeting were not ratified (this will occur at the first full meeting of the 2020 SMC on Jan 30th) and there was no Treasurer's report.

President's Report

The President presented a brief report concentrating on her concerns and vision for 2020 and beyond. These included;

- The effect of an extended hot summer on rides at both ends of the riding calendar, but specifically the two rides scheduled for March 2020. Horse welfare issues in hot weather and water supply were the major concerns.
- A lack of suitable qualified Chief Stewards in South Australia. Encouraging more members to take on this role will be a priority of the committee for 2020
- The development of a ride in the vicinity of the Mount Bold reservoir now that these facilities are open to the public. The vision is to run an 80km ride at this site in 2021 and the State Championships in 2022 as a trial event for the SA Tom Quilty that is scheduled for 2023.

Treasurer

The outgoing Treasurer (RB) requires the consent of the SMC to allow the new Treasurer (AL) to become a signatory on all bank documents and have access to Internet Banking

Proposed RB (in writing by text) Seconded MS Passed unanimously

Membership

The new Membership year has started with the rules from the 2019 Constitution in use for the first time. The option to provide a discount for those paying before Jan 31st was discussed;

<u>Motion</u> – "That the 2020 Membership fees be reduced until January 31st 2020 by the following amounts;

- Ordinary Membership by \$20 (\$140 to \$120)
- Junior Membership by \$10 (\$80 to \$70)
- Intermediate Membership by \$10 (\$80 to \$70)
- Non riding Membership by \$10 (\$65 to \$55)
- Family Membership by \$50 (\$425 to \$375)"

SAERA Policy Documents

The Committee Meetings Policy and the Disciplinary Policy were reviewed as per the requirement of the 2019 Constitution. No changes were recommended for the Disciplinary Policy. The following amendment was proposed for the Committee Meetings Policy.

Motion - "That Clause 1.2 of the SAERA CMC Committee Meetings Policy ie

'The first committee meeting for the new committee should be held as soon as practicable after the appointment of the committee at the AGM, and no later than 30 days after that AGM'

Be amended to change the 30 days to 60 days."

Proposed AL Seconded JL Passed Unanimously

JL raised a concern by some members that their image had been used without permission at the 2018 AGM. The current system has an 'opt in' for images to be used on each ride registration form (which is not without its own issues) but nothing for other SAERA gatherings.

2020 Ride Calendar

No new ride applications have been received but it was noted that it is early in the new year and the Christmas period has been challenging with many members affected directly or indirectly by bushfire, particularly the Cudlee Creek fire. This fire is not expected to impact any of the rides currently scheduled for 2020.

Jess Aistrope has been approached to run the SA State Championships at Polish Hill River on the June Long Weekend.

Other business

As noted above, many members have been affected by the 2019 Christmas bushfires in SA. In particular, long term members Bob and Christabel Gurr lost their house and all outbuildings. Of particular significance was the loss of Bob's Tom Quilty buckle from WA 2014. Several ideas we discussed as to how the SMC should respond to this tragedy.
